TERMS AND CONDITIONS

- 1. The MIAA Vehicle Access, whether temporary or sticker inform, is NON TRANSFERRABLE. The permit granted is specifically for the vehicle described in this application.
- AMA vehicle sticker is valid for one (1) year, while validity of Temporary Vehicle Entry Permit (TVEP) is stipulated in the permit itself. MIAA reserves
 the right to extend and/or revoke the validity without prior notice when such action is deemed necessary in the interest of security and safety.
- 3. It is the responsibility of the owner to: a) ensure that the authorized driver of the vehicle has a valid MIAA ID/Access Pass and Driver's Permit while inside the aircraft movement areas (AMA); b) indemnify, if at fault, the aggrieved party, pay or restore property damage caused by accident involving the vehicle applied herein; c) surrender/turn-over to the Office of the AGM for Security and Emergency Services (AGMSES) the AMAVEP/TVEP arising from sale, lease, repossession or transfer of ownership of the vehicle/s and/or separation/resignation/transfer/termination of applicant's employment from the agency/company; d) ensure that the vehicle is equipped with beacon light, and; e) ensure that the vehicle shall be operated at the designated areas only.

 4. The access herein granted may be SUSPENDED or REVOKED at the discretion of MIAA based on the following circumstances involving the owner and/or authorized driver: a) Violation of any MIAA rules and regulations, including those that may be promulgated by MIAA from time to time; b) Commission or omission of any act that may result to death, injury, and/or damage to government/private properties; c) Misrepresentations made in this application form; d) Refusal to submit the vehicle for security inspection prior to entry to or exit from the MIAA premises.
- 5. MIAA shall tow vehicles found to be illegally parked, abandoned, and/or stalled causing obstruction to traffic/airport operations or upon suspicion or information that the same poses imminent danger in the area. The owner/authorized driver shall shoulder the cost for towing services.
- 6. The owner/authorized driver apprehended for or reported to have violated MIAA rules and regulations pertaining to the use of AMA access shall pay the fines and penalties prescribed, without prejudice to the investigation MIAA deem proper to undertake.
